

## Oatley RSL & Community Club Limited Pirate Paradise Promotion Terms and Conditions.

### Entry Requirements

1. In order to participate in the promotion, persons must be a current financial member of Oatley RSL & Community Club and have their membership card inserted in a gaming machine at Oatley RSL & Community Club during the promotional period.
2. Entry is via computerised e-draw which will automatically award tickets to members at the rate of one ticket for every \$500 turnover.
3. The tickets will accumulate electronically.

### Draw

4. The draw will take place:
  - a. Every Friday from 7.30pm.
  - b. Draw times: 7.30PM, 8.00PM, 8.30PM, 9.00PM, 9.30PM
5. The members name and card number will be announced over the public address.
6. Members must be present to win, and the winning member must make themselves known to the official representative at Oatley RSL within 4 (four) minutes. If the member fails to do so in the 4 (four) minutes or is unable to meet all the terms and conditions of the Promotion, then another ticket is drawn until a winner is found.

### Prizes

7. Each winner will receive \$50 worth of bonus points.
8. Each winner will then have the opportunity to win \$500 in the "Pirates Treasure Draw"
9. The Pirates Treasure Draw is conducted in the following manner:
  - a. Is conducted immediately following the final draw of the "Pirate Paradise Draw"
  - b. Each of the five (5) contestants select 1 of 5 Gold Bars
  - c. Contestants draw in the order they won in the main draw.
  - d. Four (4) Gold bars contain "Better Luck Next Time"
  - e. One (1) Gold bar contains \$500

13. Oatley RSL reserves the right to modify the start time of the promotion on occasion as to not clash with other club promotions.
14. The following persons are not eligible to win or participate in the Badge Draw:
  - a. Any employee of Oatley RSL & Community Club Limited, either currently employed or employed within the previous 12 months of the date of the draw;
  - b. Contracted and sub contracted employees of Oatley RSL & Community Club Ltd, as well as their employees, including but not limited to Club tradesmen and the owners and employees of the caterer, whose services have been engaged in the previous 12 months of the date of the draw;
  - c. Suspended members, or any member with pending disciplinary actions against their membership;
  - d. Any non-financial member; and
  - e. Any member under the age of 18 years.
15. In the event that the winner is an individual listed in clause 14 above, a redraw will immediately occur.
16. Directors, who act in accordance with these Terms and Conditions, are eligible to participate in the promotion.
17. The member whose number is drawn must be present in the Clubhouse at the time of that said particular draw (announcement).
18. Membership cards, numbers and entry tickets are not transferrable, and only the individual named and related to the winning membership number is eligible to claim the prize.
