

Oatley RSL & Community Club Limited Sunday "Surf & Turf" Raffle Terms and Conditions.

The Sunday Raffle is held on Sundays. Ticket sales begin at 4pm and stop at 6pm. The first draw is at 6.05pm and will continue to be drawn until all prizes have been claimed.

The 'draw' constitutes the physical announcement of ticket number.

*Members must be present within and inside the physical **Clubhouse at the time of the draw (announcement) – a four (4) minute grace period to claim prize is then issued to members present in the Clubhouse should they be incapacitated at the time of the announcement.*

***The Clubhouse refers to the physical club building only situated at 23 Letitia Street, Oatley NSW 2232 and is not inclusive of Club carparks, footpaths, driveways, adjoining halls, buildings or properties.*

Rules and Conditions

In addition to the Conditions set out by the Department of Gaming and Racing the following approved rules and conditions apply:

1. The Sunday Raffle will be held every Sunday
2. Tickets will be sold from the bar tills.
3. Sales will begin at 4pm and cease at 6pm.
4. Numbers will be drawn from 6.05pm until all prizes have been claimed
5. Raffle consists of 20 prizes. Combined retail value of Raffle prizes is \$600.
6. Senior management have the right in their sole discretion and without prior notice to alter the prize structure of the draw, under the same conditions and rules, provided the combined retail value of prizes remains unchanged
7. The promotion will run from 1st July 2024 to 30th June 2025
8. To claim, patrons already present in the Clubhouse at the time of the draw must present themselves, and the ticket containing the drawn number to the raffle caller within a four (4) minute grace period
9. Unclaimed numbers will be redrawn.
10. The following persons are not eligible to win or participate in the Budget Booster Raffle:
 - a) Any employee of Oatley RSL & Community Club Limited, either currently employed or employed within the previous 12 months of the date of the draw;
 - b) Contracted and sub contracted employees of Oatley RSL & Community Club Ltd, as well as their employees, including but not limited to Club tradesmen and the owners and employees of the caterer, whose services have been engaged in the previous 12 months of the date of the draw;
 - c) Suspended members, or any members with pending disciplinary actions against their membership;
 - d) Any member or guest under the age of 18 years.
11. In the event that the winner is an individual listed in clause 10 above, a redraw will immediately occur.
12. Directors, who act in accordance with these Terms and Conditions, are eligible to claim the prize.
13. By accepting the prize, the member agrees to participate in any publicity arrangements made by or on behalf of the Club in relation to this promotion. Oatley RSL & Community Club reserves the right to publicise the winners' names and photograph through print, electronic media and broadcasts without permission or payment of any compensation to the winner and without prior notification.
14. To the extent permissible by law, members release Oatley RSL & Community Club from any causes of action, loss, liability, damage, expense (including claim for legal expense), cost or charge sustained or in any way incurred, as a result of participation in this promotion.
15. Oatley RSL & Community Club in its sole and reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in
